

TOWN OF WINDSOR PARK RENTAL RATES

Town of Windsor Parks can be reserved on a first-come first serve basis. Town of Windsor Parks are open seven days a week, year-round from sunrise to sunset. A completed application along with a security deposit and application fee is due to reserve date and at time application is submitted.

Security Deposit (refundable):

Below are park use permit fees assessed to groups or individuals for the use of a group picnic area or a portion of a park amenity for the following activities: private parties, family reunions, weddings, receptions, and non-profit organizations special events

Non-profit Youth Sport Organizations:

Non-profit groups that offer youth sport activities (through high school age) shall be assessed a per participant fee, per sport season. A park use application for each field, court and/or park use is required. Each special event, such as “Opening Day,” “Tournaments” etc. will require a separate Park Use application.

Adult Athletics:

Adult sport activities (18 years and older) shall be assessed a Park Use Permit fee based on number of players and audience in attendance, a field use fee and refundable deposit.

Storage units are 10 x 12 in size.

Reservation Policy – reservations are accepted and valid upon the following:

1. Completion of Town’s Park Use Application.
2. Deposit and the application fee submitted to the Parks and Recreation Department with application.
3. Reservations may be made up to one (1) year in advance.

Cancellation Policy:

1. If a reservation is canceled sixty (60) days or more prior to event, 50% of the deposit will be returned.
2. If reservation is canceled between thirty-one (31) and fifty-nine (59) days prior to event, no deposit will be returned.
3. If reservation is canceled thirty (30) or fewer days prior to event, the deposit and all fees paid will not be returned.
4. Refunded deposits (or a portion thereof) will be mailed within six (6) weeks after cancellation.
