

**RESOLUTION NO. 3157-14**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR  
PRIORITIZING A TOWN PROJECT FOR COMMUNITY DEVELOPMENT BLOCK  
GRANT FUNDING AND AUTHORIZING THE SUBMITTAL OF A FUNDING  
APPLICATION TO THE SONOMA COUNTY COMMUNITY DEVELOPMENT  
COMMISSION FOR FISCAL YEAR 2015-16**

**WHEREAS**, the Community Development Commission (CDC) administers the Community Development Block Grant (CDBG) program grant funds received from the United States Secretary of Housing and Urban Development (HUD) under Title I of the Housing and Community Development Act of 1974, objectives of which include improving communities by providing decent housing and a suitable living environment, and expanding economic development opportunities, principally for persons of low and moderate income; and

**WHEREAS**, the Town of Windsor participates in the CDBG program administered by the CDC pursuant to a Joint Powers Agreement (JPA); and

**WHEREAS**, the CDC receives approximately \$1.5-\$2.0 Million in CDBG funds annually from HUD, of which approximately 30.5% will be allocated on a competitive basis to the seven incorporated cities that participate in the JPA; and

**WHEREAS**, the Town of Windsor will review CDBG project proposals and prepare an application for submission to the CDC requesting CDBG funding for the Town's priority project; and

**WHEREAS**, the Town of Windsor acknowledges that residents of the Town may submit an application for the Countywide Housing Rehabilitation program and will be considered, on a first come, first served basis, for funding from the general Countywide Housing Rehabilitation Program funds or from funds derived from City/Town reprogrammed funds earmarked specifically for use within the boundaries of the incorporated areas participating in the Urban County, subject to funding availability.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of Windsor has reviewed the CDBG project proposals and designates the Starr Road Sidewalk Windsor River Road to Vivian Court ADA Sidewalk Improvement Project as its number one priority project; and the Town Green Playground ADA Retrofit Improvement Project as its number two priority project; and


**BE IT FURTHER RESOLVED** that the Town Council of the Town of Windsor approves the submission of an application to the CDC for the Town's priority project for CDBG funds for FY 2015-16 and hereby authorizes the Town Manager or her designee to execute all necessary agreements with the CDC including environmental review for implementation of said Project.
