

RESOLUTION NO. 3273-16

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR APPROVING AN AGREEMENT NOT TO EXCEED \$150,000 WITH R3 CONSULTING GROUP, INC. TO PROVIDE TECHNICAL ASSISTANCE IN DEVELOPING AND EVALUATING PROPOSALS FOR A NEW SOLID WASTE, GREEN WASTE, ORGANIC WASTE AND RECYCLABLES EXCLUSIVE FRANCHISE; AND TEMPORARY DEBRIS BOX AND ROLL-OFF NON-EXCLUSIVE FRANCHISE(S) AND AUTHORIZE THE TOWN MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE TOWN

WHEREAS, on June 20, 2007, the Town contracted with Windsor Refuse and Recycling, Inc. (“WR&R”) for exclusive collection, processing, recycling and disposal of residential and commercial solid waste; and

WHEREAS, the exclusive franchise agreement will expire on September 30, 2017; and

WHEREAS, in January 1, 2008, the Town contracted for non-exclusive franchises with Ratto Group of Companies, Industrial Carting, and M&M Services Inc. for temporary debris box and roll off collection services; and

WHEREAS, the non-exclusive franchises will expire on December 31, 2017, and cannot be extended; and

WHEREAS, the Town is required to issue a Request for Proposal (“RFP”) for a competitive formal bid process; and

WHEREAS, Town staff reviewed the proposals for the technical assistance and has concluded that R3 Consulting Group, Inc. (“R3”) is the best qualified consultant to perform the requested work; and

WHEREAS, R3’s services are not to exceed \$150,000 for this technical assistance.

NOW, THEREFORE, BE IT RESOLVED that the Windsor Town Council approves an Agreement with R3 Consulting Group, Inc., in the not-to-exceed amount of \$150,000 for Technical Assistance in Developing and Evaluating Proposals for a New Solid Waste, Green Waste, Organic Waste and Recyclables Exclusive Franchise; and Temporary and Roll-Off Service Non-Exclusive Franchise(s) and authorizes the Town Manager to execute said Agreement on behalf of the Town.
