

**RESOLUTION NO. 3352-17**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR  
AUTHORIZING A REIMBURSEMENT IN AN AMOUNT NOT TO EXCEED THREE  
HUNDRED DOLLARS FOR PROMOTION OF THE TOWN IN CONNECTION WITH  
THE SYMETRA LPGA TOUR IN WINDSOR**

**WHEREAS**, during the week of April 3, 2017 the LPGA (“Ladies Professional Golf Association”) Symetra Tour is holding its inaugural POCMED Golf Classic (the “Event”) at the Windsor Golf Club; and

**WHEREAS**, the Symetra LPGA tour has not been held in Northern California since 2001; and

**WHEREAS**, 144 participants and their guests from throughout the United States and over 25 other countries are expected to visit Windsor in connection with the Event; and

**WHEREAS**, Symetra is the official qualifying tour for the LPGA, and the Event has a \$100,000 purse; and

**WHEREAS**, in recognition of the economic benefit to Windsor and environs as a result of the Event, Sonoma County Tourism has contributed \$5,000 toward the Event; and

**WHEREAS**, the Town is hopeful that the LPGA may schedule future Tours in Windsor, with resulting future economic benefit to the community; and

**WHEREAS**, Christopher Creek Winery hosted a complimentary wine-tasting reception for Event attendees on April 3, 2017; and

**WHEREAS**, approximately 2,000 Event visitors are expected in Windsor from April 3 through April 11, 2017, with projected economic benefits to Town hotels, restaurants and shops; and

**WHEREAS**, the Town provided refreshments (excluding alcohol) for the reception on April 3, 2017, as a gesture of hospitality and in recognition to the economic benefit to the Town of Windsor from the Event as well as the potential for future economic benefit; and

**WHEREAS**, funds are available in the General Fund for this purpose.

**NOW, THEREFORE BE IT RESOLVED** that the Town Council of the Town of Windsor does hereby resolve as follows:

Section 1. The above recitals are true and correct, and are incorporated herein by reference.

Section 2. The reimbursement of an amount not to exceed \$300 from the Town’s General Fund for the provision of refreshments at the April 3, 2017 Event reception is hereby authorized.
