

ORDINANCE NO. 2008-243

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR
AMENDING TITLE IV ARTICLE 7 OF THE
MUNICIPAL CODE OF THE TOWN OF WINDSOR
PERTAINING TO SPEED LIMITS**

**THE TOWN COUNCIL OF THE TOWN OF WINDSOR DOES HEREBY ORDAIN AS
FOLLOWS:**

SECTION 1. Sections 4-5-710 through 4-5-740 of the Town Code (Ordinance No. 93-43 part) are amended to read as follows:

4-5-720 Thirty-Five (35) Miles Per Hour. The following portions of the Town Streets are hereby declared to have a prima facie speed limit of thirty-five (35) miles per hour:

Arata Lane	From Troon Court to Foothill Drive
Bell Road	From Conde Lane to terminus
Brooks Road	From Arata Lane to Adele Drive
Brooks Road	From Adele Drive to Lakewood Drive
Cameron Drive	From Mitchell Lane to Bell Road
Hembree Lane	From Old Redwood Highway to Wilson Lane
Hembree Lane	From MacFarlane N to MacFarlane S
Old Redwood Highway	From U.S. 101 to Windsor Road
Old Redwood Highway	From Hembree Lane to U.S. 101
Reiman Lane	From Starr Road to Windsor Road
Starr Road	From Old Redwood Highway to Starrview Drive
Starr Road	From Starrview Drive to Windsor River Road
Starr Road	From Windsor River Road to Reiman Lane
Vinecrest Road	From Hembree Lane to Vinecrest Circle
Windsor River Road	From Starr Road to Windsor Road
Windsor Road	From Windsor River Road to Reiman Lane

4-5-725 Forty (40) Miles Per Hour. The following portions of the Town Streets are hereby declared to have a prima facie speed limit of forty (40) miles per hour:

Arata Lane	From Old Redwood Highway to Los Amigos Road
Arata Lane	From Los Amigos Road to Troon Court
Conde Lane	From Old Redwood Highway to Mitchell Lane
Conde Lane	From Shiloh Road to Mitchell Lane
Hembree Lane	From Foothill Drive to Vinecrest Road
Hembree Lane	From Vinecrest Road to Old Redwood Highway
Los Amigos Road	From Arata Lane to Cordellia Lane
Old Redwood Highway	From Arata Lane to North Town Limi
Old Redwood Highway	From Windsor Road to Arata Lane
Shiloh Road	From U.S. 101 to Old Redwood Highway
Skylane Boulevard	From Shiloh Road to Town Limit
Windsor Road	From Shiloh Road to Reiman Lane

SECTION 2. This Ordinance shall take affect and be in force thirty (30) days from and after the date of its passage. The Town Clerk shall cause this Ordinance to be published or be posted in at least three (3) public places in Town in accordance with Section 36933 of the Government Code of the State of California.
