

RESOLUTION NO. 3640-20

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON
NOVEMBER 3, 2020, DECLARING THE RESULT AND SUCH OTHER MATTERS AS
PROVIDED BY LAW, AND THEREBY DETERMINING THAT DEBORA FUDGE HAS
BEEN ELECTED TO THE OFFICE OF MEMBER OF THE WINDSOR TOWN
COUNCIL FOR DISTRICT 3 AND DOMINIC FOPPOLI HAS BEEN ELECTED TO
THE OFFICE OF AT-LARGE MAYOR OF THE WINDSOR TOWN COUNCIL**

WHEREAS, a General Municipal Election was held and conducted in the Town of Windsor, Sonoma County, California, on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received, and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Sonoma County Registrar of Voters canvassed the returns of the election and has certified the results to this Town Council.

NOW, THEREFORE BE IT RESOLVED that the Town Council of the Town of Windsor does resolve and order as follows:

Section 1. The whole number of ballots for the office of Councilmember of the Town Council for District 3 cast in the 5 precincts was 3,711. The whole number of ballots for the office of At-large Mayor of the Town Council cast in the 35 precincts was 15,173.

Section 2. The following named were candidates voted for at the election for Councilmember of the Town Council for District 3:

Section 3. The Town Council does declare and determine that the following named was elected as Councilmember of the Town Council for District 3 for the full term of four years:

DEBORA FUDGE

The Town Council does declare and determine that the following named was elected as At-large Mayor of the Town Council for the full term of two years:

DOMINIC FOPPOLI

Section 4. The number of votes given at each precinct to each person and the respective total votes cast for each person are contained in Exhibit A, Statement of the Votes Cast at the Town of Windsor Consolidated General Election held on November 3, 2020, and incorporated herein by reference.

Section 5. The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the results of the election, showing: 1) the whole number of ballots cast in the Town; 2) the names of the persons voted for; 3) for what office each person was voted for; 4) the number of votes given at each precinct to each person and 5) the total number of votes given to each person.

Section 6. The Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; the Town Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the Town Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7. The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
