

RESOLUTION NO. 3672-21

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR
RECITING THE FACT OF THE SPECIAL ELECTION HELD ON MAY 4, 2021
WHOLLY BY MAIL, DECLARING THE RESULT AND SUCH OTHER MATTERS
AS PROVIDED BY LAW, AND THEREBY DETERMINING THAT
ROSA REYNOZA HAS BEEN ELECTED TO THE OFFICE OF COUNCILMEMBER
OF THE WINDSOR TOWN COUNCIL FOR THE REMAINDER OF A FOUR-YEAR
TERM THAT WILL EXPIRE DECEMBER OF 2022**

WHEREAS, a Special Election was held and conducted wholly by mail in the Town of Windsor, Sonoma County, California, on Tuesday, May 4, 2021, as required by law; and

WHEREAS, notice of the special election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted wholly by mail and the votes were cast, received, and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Sonoma County Registrar of Voters canvassed the returns of the special election and has certified the results to this Town Council.

NOW, THEREFORE BE IT RESOLVED that the Town Council of the Town of Windsor does resolve and order as follows:

Section 1. The whole number of ballots for the office of Councilmember of the Town Council cast in the 39 precincts was 6,859.

Section 2. The following named were candidates voted for at the special election for Councilmember of the Town Council:

JEFFREY LEASURE
CODY WILSON
JULIA DONOHO
OSCAR CHAVEZ**

Section 3. The Town Council does declare and determine that the following named was elected as Councilmember of the Town Council for the remainder of a four-year term that will expire December of 2022:

Section 4. The number of votes given at each precinct to the person and the respective total votes cast for the person are contained in Exhibit A, Statement of the Votes Cast at the Town of Windsor Special Election held on May 4, 2021, and incorporated herein by reference.

Section 5. The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the results of the election, showing: 1) the whole number of ballots cast in the Town; 2) the name of the person voted for; 3) for what office the person was voted for; 4) the number of votes given at each precinct for the person and 5) the total number of votes given to the person.

Section 6. The Town Clerk shall immediately make and deliver to the person so elected a Certificate of Election signed by the Town Clerk and authenticated; the Town Clerk shall also administer to the person elected the Oath of Office prescribed in the Constitution of the State of California and shall have the person subscribe to it and file it in the office of the Town Clerk. The person so elected shall then be inducted into the respective office to which they have been elected.

Section 7. The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

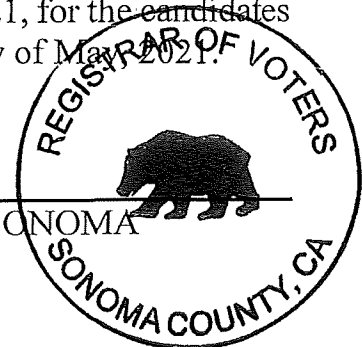
