

**RESOLUTION NO. 3804-22**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR  
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON  
NOVEMBER 8, 2022, DECLARING THE RESULT AND SUCH OTHER MATTERS AS  
PROVIDED BY LAW, AND THEREBY DETERMINING THAT  
ROSA REYNOZA HAS BEEN ELECTED TO THE OFFICE OF AT-LARGE MAYOR,  
MIKE WALL HAS BEEN ELECTED TO THE OFFICE OF COUNCILMEMBER  
DISTRICT 1, SAM SALMON HAS BEEN ELECTED TO THE OFFICE OF  
COUNCILMEMBER DISTRICT 2, AND TANYA POTTER HAS BEEN ELECTED TO  
THE OFFICE OF COUNCILMEMBER DISTRICT 4**

**WHEREAS**, a General Municipal Election was held and conducted in the Town of Windsor, Sonoma County, California, on Tuesday, November 8, 2022, as required by law; and

**WHEREAS**, notice of the election was given in time, form and manner as provided by law; voting centers were properly established; election officers were appointed and in all respects the election was held and the votes were cast, received, and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, the Sonoma County Registrar of Voters canvassed the returns of the election and has certified the results to this Town Council.

**NOW, THEREFORE BE IT RESOLVED** that the Town Council of the Town of Windsor does resolve and order as follows:

**Section 1.** The Town Clerk of the Town of Windsor, as the Town's Election Official, has certified that the results presented are true and correct to the best of their knowledge based on documents produced by the Sonoma County Registrar of Voters.

**Section 2.** The whole number of ballots for the office of At-Large Mayor of the Town of Windsor cast was 10,038. The whole number of ballots for the office of Councilmember District 1 was 2,197. The whole number of ballots for the office of Councilmember District 2 was 3,071. The whole number of ballots for the office of Councilmember District 4 was 2,420.

**Section 3.** The following named, by list of appearance on the ballot, were candidates voted for at the election for At-Large Mayor:

The Town Council does declare and determine that the following named was elected as Councilmember District 1 of the Town Council for a four-year term that will expire December of 2026:

**MIKE WALL**

The Town Council does declare and determine that the following named was elected as Councilmember District 2 of the Town Council for a two-year term that will expire December of 2024:

**SAM SALMON**

The Town Council does declare and determine that the following named was elected as Councilmember District 4 of the Town Council for the remainder of a four-year term that will expire December of 2026:

**TANYA POTTER**

**Section 5.** The number of votes given, and the respective total votes cast for the person are contained in Exhibit A, Statement of the Votes Cast at the Town of Windsor General Municipal Election held on November 8, 2022 and incorporated herein by reference.


**Section 6.** The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the results of the election, showing: 1) the whole number of ballots cast in the Town; 2) the name of the person voted for; 3) for what office the person was voted for; 4) the total number of votes given to the person.

**Section 7.** The Town Clerk shall immediately make and deliver to the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; the Town Clerk shall also administer to the persons elected the Oath of Office prescribed in the Constitution of the State of California and shall have the persons subscribe to it and file it in the office of the Town Clerk. The persons so elected shall then be inducted into the respective office to which they have been elected.

**Section 8.** The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
