

RESOLUTION NO. 2583-09

**A RESOLUTION OF THE TOWN COUCIL OF THE TOWN OF WINDSOR
AUTHORIZING THE TOWN MANAGER TO EXECUTE AN AGREEMENT
WITH THE WINDSOR GARDEN CLUB FOR THE USE
OF THE CIVIC CENTER WEST PROPERTY FOR
OPERATING A COMMUNITY GARDEN**

WHEREAS, a community garden supports the Town of Windsor's efforts to be Green by bringing people together, fostering healthy and active lifestyles, offering educational and voluntary opportunities and conserving green space; and

WHEREAS, on December 17, 2008, Council approved a concept to develop a community garden; and

WHEREAS, Town staff facilitated public meetings and workshops to solicit input and interest from residents and community partners in the development a Community Garden; and

WHEREAS, on April 8, 2009, the Parks and Recreation Commission recommended to Town Council the development of a Phase I Demonstration Garden located in the Town Hall Courtyard and a Phase II Community Garden located on the Civic Center West Property; and

WHEREAS, on May 6, 2009, Council approved the location, design, and administration of a Phase I Demonstration Garden located in the Town Hall Courtyard and a Phase II Community Garden located on the Civic Center West Property.

WHEREAS, on May 20, 2009, Council held a Budget Workshop and recommended that the Phase II Community be included in the Capital Improvement Program for FY 09-10 in the amount of \$15,000 to be funded by the Park Development Fund; and

WHEREAS, the FY 09-11 Budget was approved on June 3, 2009; and

WHEREAS, on September 2, 2009, Council directed staff to proceed with the \$15,000 budgeted for the Phase II Community Garden with the understanding that the Community Garden would be turned over to the Garden Club; and


WHEREAS, the Garden Club has as a goal to further fund and develop the Community Garden; and

WHEREAS, the Garden Club and Town desire to enter into a Use Agreement upon which the terms and conditions for the use of the Civic Center West Property is identified.

NOW, THEREFORE BE IT RESOLVED that the Town Council authorized the Town Manager to execute a Use Agreement with the Windsor Garden Club for use of the Civic Center West Property for operating a Community Garden.
