**A RESOLUTION OF THE BOARD OF DIRECTORS OF  
THE REDEVELOPMENT AGENCY OF THE TOWN OF WINDSOR  
ADOPTING THE 5-YEAR IMPLEMENTATION PLAN FOR THE WINDSOR  
REDEVELOPMENT PROJECT 2010-2014**

**WHEREAS**, on October 6, 1993, Governor Wilson signed into law Assembly Bill 1290, the Community Redevelopment Law Reform Act of 1993, which became effective on January 1, 1994; and

**WHEREAS**, Assembly Bill 1290 added Sections 33490 (a) and 33490 (c) to the California Health & Safety Code; and

**WHEREAS**, California Health & Safety Code Section 33490 requires that each Redevelopment Agency adopt, after a public hearing, a 5-year implementation plan; and

**WHEREAS**, in accordance with Assembly Bill (AB) 1290, the Windsor Redevelopment Agency ("Agency") adopted its first Implementation Plan in 1995; and

**WHEREAS**, the Implementation plan contains goals, objectives, programs, expenditures, and a description of how goals and objectives, programs and expenditures will eliminate blight within the Windsor Redevelopment Project Area ("Project Area"); and

**WHEREAS**, the Implementation plan includes an Affordable Housing Plan which describes how the Agency will increase, improve, and preserve low and moderate-income housing in the Project Area; and

**WHEREAS**, on December 2, 2009, a duly noticed public hearing conducted pursuant to Government Code Section 6063 and California Health and Safety Code Section 33490(d) was held to take public testimony and discuss the Five-Year Implementation Plan for the Windsor Redevelopment Project 2010-2014.

**NOW, THEREFORE, BE IT RESOLVED** that the Windsor Redevelopment Agency of the Town of Windsor hereby adopts the Five-Year Implementation Plan for the Windsor Redevelopment Project 2010-2014 pursuant to the requirements of California Health & Safety Code Section 33490 a true and correct copy of which is on file with the Town Clerk/Town of Windsor Redevelopment Agency Clerk and incorporated herein by this reference as the Five-Year Implementation Plan for the Windsor Redevelopment Agency.
