

RESOLUTION NO. 2719-10

**A RESOLUTION OF THE TOWN COUNCIL
OF THE TOWN OF WINDSOR ADOPTING FEES FOR
ANIMAL CARE AND CONTROL SERVICES FOR FY 2010-2011.**

WHEREAS, the Town Council for the Town of Windsor has adopted the Town of Windsor Animal Regulations Ordinance, codified as Chapter 4 of Title III of the Code of the Town of Windsor; and

WHEREAS, Title III, Chapter 4, Article 1, Section 115 authorizes the Town Council to establish a schedule of fees and charges for services provided by the County of Sonoma under the Animal Regulations Ordinance; and

WHEREAS, pursuant to Title III, Chapter 4, Article 1, Section 115 the fees and charges established may recover the reasonable cost of providing such services and issuing such licenses; and

WHEREAS, these fees were established by Resolution No. 111-92 on December 9, 1992, revised by Resolution No. 734-98 on June 17, 1998, revised by Resolution No. 1016-01 on April 11, 2001, revised by Resolution No. 1750-05 on April 20, 2005, revised by Resolution No. 2012-07 on January 17, 2007 and further revised by Resolution No. 2136-07 on September 19, 2007 and by Resolution No. 2301-08 on June 18, 2008 at the same rates charged within the unincorporated area for similar services provided by the County of Sonoma; and

WHEREAS, the fee increases are due to a workload increase and overhead costs; and

WHEREAS, the proposed County fees were approved by the Sonoma County Board of Supervisors on April, 20, 2010; and

WHEREAS, the Town Council desires to increase the cost recovery rate of the Animal Care and Control Services by charging an additional Administration Fee, therefore reducing the impact to the General Fund Budget,

NOW, THEREFORE, BE IT RESOLVED that the fees for animal control and field services within the Town of Windsor shall be as follows:


BE IT FURTHER RESOLVED that the Town Manager has the authority to modify and/or waive fees based on good cause and in the interest of justice.
