

**RESOLUTION NO. 2754-10**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR  
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION  
HELD ON NOVEMBER 2, 2010,  
DECLARING THE RESULT AND SUCH OTHER MATTERS  
AS PROVIDED BY LAW  
AND  
THEREBY DETERMINING THAT ROBIN GOBLE, SAM SALMON AND  
STEVE ALLEN HAVE BEEN ELECTED TO THE OFFICE OF MEMBER OF THE  
WINDSOR TOWN COUNCIL**

**WHEREAS**, a General Municipal Election was held and conducted in the Town of Windsor, Sonoma County, California, on Tuesday, November 2, 2010, as required by law; and

**WHEREAS**, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received, and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, the County of Sonoma Registrar of Voters canvassed the returns of the election and has certified the results to this Town Council.

**NOW, THEREFORE**, the Town Council of the Town of Windsor, California, does resolve and order as follows:

Section 1. That the whole number of ballots for the office of Member of the Town Council cast in the precinct except vote by mail ballots was 2879.

Section 2. That the whole number of vote by mail ballots cast in the Town for the office of Member of the Town Council was 6690 and the whole number of voter ballots cast in the Town was 9569, making a total of ballots cast in the Town of Windsor for Member of the Town Council.

Section 3. That the names of the persons voted for at the election for Member of the Town Council are as follows:

**Robin Goble  
Sam Salmon  
Steve Allen**

Section 4. The Town Council does declare and determine that Robin Goble, Sam Salmon and Steve Allen were elected as Members of the Town Council for the full term of four years.

Section 5. That the number of votes given at each precinct to each person and the respective

total votes cast for each person are contained in Exhibit A, Statement of the Votes Cast at the Town of Windsor Consolidated General Election held on November 2, 2010.

Section 6. The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the result of the election, showing: 1) the whole number of ballots cast in the Town; 2) the names of the persons voted for; 3) for what office each person was voted for; 4) the number of votes given at each precinct to each person and 5) the total number of votes given to each person.

Section 7. The Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; that the Town Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the Town Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 8. The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.



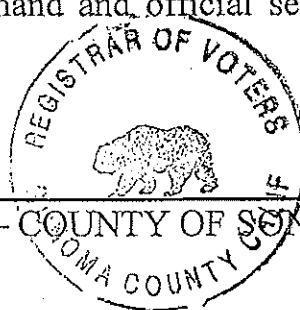
